Climate adaptability

Technology is the need of the hour for India and the world to mitigate the devastating impact of climate change, said the Secretary, MoEFCC, Leena Nandan on Friday. Speaking at a panel Discussion on "Technology Needs Assessment for Sustainable Life" at the India Pavilion at COP 27, she said, "Climate change is not an issue confined to those who are seen as emitters and there is now a realisation and larger and uniform understanding that Climate change cannot be wished away. It is knocking at our door." She reiterated the need to work through silos and also stated that technology cannot remain confined to big players due to their access to finance, adding that MSMEs and start ups need to be enabled to access technology optimally. Stating that climate change is leading

to devastation in the form of several nature based occurrences, Leena Nandan said "Our lifestyles need to change to respond to the challenges that we are facing". She said, "that our discussions need to now focus on bridging the gaps between what we want to achieve and how to achieve it". Secretary MoEFCC said that science is there but how to apply this science and knowledge to our activities needs to be processed. Speaking in the context of technologies in road construction she said that one size fits all cannot apply to India due to India's huge diversity. Technology needs assessment is different in different states. The Secretary also spoke about the circular economy. Reduce, reuse, recycle, restore and refurbish. All R's need the T that is technology, she said. She urged DST to engage with

State Governments to come up with innovative solutions. "We need to add our bits in the larger picture only then as a country we could say that we have taken decisive steps to tackle Climate Change," she concluded. India set up a pavilion with the theme of "LiFE- Lifestyle for Environment" at the ongoing 27th Session of Conference of Parties of the UNFCCC (COP 27) Sharm El-Sheikh, Egypt. Prime Minister Narendra Modi coined the concept of LiFE - Lifestyle for the Environment - at the United Nations Climate Change Conference (COP26) held in Glasgow November last year. The LiFE movement seeks to transform persons into 'pro-planet people', who would adopt sustainable lifestyles in the modern world.

Shimla, Nov 12: After high-pitched campaign by political heavyweights, Himachal Pradesh is set to vote on Saturday with political commentators predicting a close contest. Over 55 lakh voters in the hilly state will exercise their franchise from 8 am to decide the fate of 412 candidates on 68 assembly constituencies. This includes Chief Minister Jai Ram Thakur, former Chief Minister Virbhadr Singh's son Vikramaditya Singh and former BJP chief Satpal Singh Satti among others. Tight security arrangements have been made in all 68 assembly constituencies for the

election day. The Election Commission has set up 7,884 polling stations including three in high altitude zones. According to the Election Commission, there are 1.86 lakh first-time voters, 1.22 lakh aged 80-plus, and 1,184 voters who are above 100 years of age in the state. The elections in Himachal Pradesh are being conducted in one single phase and results will be declared on December 8. The Assembly term in state will end on January 8 (Sunday). The BJP is in power in the State under the leadership of Jai Ram Thakur, the current Chief

Minister of the state. The party has 44 MLAs in the 68 seat Himachal Assembly, while the Congress has 21 MLAs. Two MLAs are Independents and the CPM has one seat. No incumbent Government has returned to power in Himachal Pradesh for a second consecutive term since 1982. Therefore, the challenge for the ruling BJP is to buck the anti-incumbency factor and overturn the convention. The Congress is banking on the voters to go with the four decade old trend in the state. Prime Minister Narendra Modi himself set the momentum for the BJP

with several visits in the last month. He inaugurated a Vande Bharat train and the AIIMS at Bilaspur to project the advantages of a "double engine" government. Himachal Pradesh is also being considered a prestige battle for BJP national president J.P. Nadda. The entire electoral campaign of the party revolved around his choices, be it in ticket distribution or in strategy. When it comes to campaigning in the state, the Congress has mainly remained dependent on Priyanka Gandhi Vadra in absence of Rahul Gandhi who is currently busy in a months long Bharat Jodo Yatra.

The Congress has faced defeats in nine states over a period of two years. In 2021, the party lost West Bengal, Kerala, Assam, Puducherry and this year the grand old party has lost Punjab, Uttar Pradesh, Uttarakhand, Goa and Manipur. Himachal is known to have bipolar contests between the BJP and Congress. However, the entry of Aam Aadmi Party could make the contest triangular in some assembly segments this time. Meanwhile, the Meteorological Department predicted clear weather in Himachal on the day of polling on Saturday.

Kerala to host global forum on drug-free childhood

Thiruvananthapuram, Nov 12: The November 16 to 18 international forum on drug-free childhood will formulate a strategy for effectively advocating with governments for necessary policy and legislative interventions based on the Article 33 of the United Nations Convention on the Rights of the Child (UNCRC), which obligates States parties to protect children and youth from involvement with illicit drugs and drug trade. The meet, 'Children Matter - Right to a Drug-Free Childhood', featuring speakers from across the world, is being organised by Fourth Wave Foundation (FWF) in

partnership with United Nations Office on Drugs and Crime (UNODC) and World Federation Against Drugs (WFAD). By focusing on Article 33, which calls for steps to protect children from the use of narcotic drugs and psychotropic substances, the meet aims at underscoring the need to create a substance abuse free environment for children world-wide, according to C.C. Joseph, Director, FWF. The action plan advocating urgent measures to save children from falling prey to drugs, to be drawn up by the meet based on three days of extensive deliberations, will emphasise the need to step up awareness

about Article 33 among all sections of people and ask governments to frame policies to further strengthen its implementation, he said. Plenary sessions of the forum will have speakers, including Regina Mattsson, Secretary General, WFAD, Sweden, Amy Ronshausen, international President, WFAD, USA, civil society members, policymakers, child rights advocates, government representatives, prevention-treatment-recovery professionals and youth leaders from across the globe. FWF's own initiative "Project VENDA", which seeks to empower children and young adults

to say 'No' to drugs, will figure prominently in one of the sessions dealing with global best practices in containing substance abuse by empowering children and young adults, FWF Director Diana Vincent said.

Janasena chief meets Modi, says good days ahead for AP

Visakhapatnam, Nov 12: Film actor turned politician and Janasena chief K. Pawan Kalyan called on Prime Minister Narendra Modi in the East Naval Command's guest house on the night of Friday. After a meeting with Prime Minister Narendra Modi, Pawan Kalyan told the media that he believes that good days will come to Andhra Pradesh in the coming days. "I strongly believe that this meeting with the Prime Minister will help to bring good days to AP. Prime Minister enquired me about many issues. I have apprised him as per my understanding. The

meeting with the Prime Minister was held under special circumstances," Pawan Kalyan clarified. "Prime Minister Modi's wish is that all the Telugu people and the SP state should prosper and the Telugu people should be united," he stated.
